Transport Department - Implementation of Installation of High Security Registration Plates (HSRP) on Motor Vehicles Registered Prior to 01.04.2019 in the State of Chhattisgarh.

The Government of Chhattisgarh, exercising the power as laid to the State Government under Section 41(6), Section 47, Section 48, Section 64, Section 65, Chapter IV of The Motor Vehicles Act, 1988 have proposed to implement the revised Rule 50 of the Central Motor Vehicles Rules, 1989, as notified by the Government of India, Ministry of Road Transport and Highways vide S.O. 6052 (E) Dated 06th December 2018, Motor Vehicles (High Security Registration Plates) Order, Clause 5(ii), S.O No. 1018 (E) dated 25.02.2019, G.SR No. 749(E) dated 07.08.2019, G.S.R No. 104(E) dated 11.02.2020, S.O 1759 dated 05.06.2020, GSR 640(E) dated 18.08.2022 and other subsequent notifications issued time to time for implementation of High Security Registration Plate system in India for all types of vehicles registered prior to 01.04.2019 in the State.

On behalf of the Government of Chhattisgarh, the Transport Commissioner in compliance to the directions issued by the Hon'ble Supreme Court of India issues the following order

1. The Government of Chhattisgarh have selected and approved M/s Real Mazon India Pvt. Ltd. for Zone 1 and M/s. Rosmerta Safety Systems Ltd. for Zone 2, to implement High Security Registration Plates in State at the prices fixed including the applicable duties and Taxes as approved below:-

- 2. All payment should made through digital mode only.
- 3. The High Security Registration Plate will be provided to the motor vehicle owners as per as per RTO code in Zone 1 and Zone 2 and will be affixed by M/s Real Mazon India Pvt. Ltd. and M/s. Rosmerta Safety Systems Ltd. (Copy annexed as Annexure A)
- 4. The High Security Registration Plates (including the third registration Plate required) for existing vehicles registered prior to 01/04/2019 shall also be affixed attheautomobile dealerspremiseon an additional cost of Rs. 100/- per fitment and at home services, at an additional cost, if opted by the vehicle owners.
- 5. For all class of vehicles registered prior to 1st April, 2019, the vehicle owner shall have to take necessary steps to get the HSRP affixed on their vehicle.
- 6. All the automobile dealers shall facilitate the affixation of HSRPs onto the existing vehicles at their premise. Directions in this regard will be issued separately.
- 7. The Registering Authorities are required to strictly implement the directions of the Transport Commissioner and
 - a. Shall give wide publicity to the HSRP fitment drive on exiting vehicles in print & electronic media.
 - b. Shall ensure that all Existing Transport Vehicles will be converted to HSRP within a period of 1 year from the date of issuance of the notification. Fitness certificate to only those vehicles be issued which are affixed with HSRP Plates.
 - c. Shall ensure that all the activities in RTO offices related to transfer of vehicle, Address/HP Change, Insurance update, Fitness issuance etc. will be allowed only after ensuring that the HSRP is affixed on the vehicle.
 - d. Shall ensure that the vehicles be issued challan in the districts if found not affixed with HSRP within prescribed time.

- 8. However, to avoid last minute rush, vehicle owners should be encouraged/sensitized to affix HSRP on their vehicles as soon as possible within 120 days/19/03/2025 from the date of issuance of the notification. Post this date, authorities shall strictly enforce compliance of HSRPs on all vehicles as per the prevailing Act and Rules.
- 9. If the vehicle owner does not comply with the directions issued by Chattisgarh Transport Department, penalties shall be imposed on the vehicles as per the prevailing Acts and Rules.
- 10. Vehicle plying on the road fitted with imitation HSRP/look alike plates/smart number plates such as hologram/IND mark/ "INDIA" inscription etc. shall mandatorily replace their registration plates with High Security Registration Plates conforming to Rule 50 of CMVR, 1989 to avoid penalty under provisions of the Motor vehicles Act, 1988.
- 11. Legal action shall be initiated against Dealers/any other person found to be selling and supplying HSRPs in the State without being authorised.
- 12. To achieve the objectives the Government of Chhattisgarh may from time to time issue instructions to regulate the installation of High Security Registration Plates for the motor vehicles.
